Motion to approve Resolution #15-034 Setting Fees for the Collection of Refuse & Recyclable Materials from Multifamily, Commercial, Retail and Industrial Establishments.

COMMENTS

1. These fees will be charged according to the amount of trash cans collected at each establishment.
2. This came about as a result of our efforts in auditing all of the Establishments in the Township for their compliance to our ordinances involving recycling.
3. The rates in the Resolution will be charged Quarterly as follows: (1) 95 gal can = \$85.00; (1) 95 gal can + (1) 65 gal can = \$112.00; (2) 95 gal cans = \$145.00; (3) 95 gal cans = \$240.00; (2) 95 gal cans + (1) 65 gal can = \$160.00 & (4) 95 gal cans = \$280.00.
4. We can anticipate the number of cans needed by an establishment for their volume of Refuse and deliver the appropriate cans to the establishment prior to billing.

RESOLUTION #15-034

THE TOWNSHIP OF ABINGTON

WHEREAS, Ordinance 1659 Section 92-23 provides that the Collection of Refuse Materials by Abington Township from Multifamily, Commercial, Retail and Industrial Establishments shall be set by Resolution and;

WHEREAS, Said fee shall be collected on a quarterly basis and;

NOW THEREFORE BE IT RESOLVED, That the Township of Abington on this 12th day of November 2015, that the fees for the collection of Recyclable Materials shall be set at a rate of (1) 95 gal can = \$85.00; (1) 95 gal can + (1) 65 gal can = \$112.00; (2) 95 gal cans = \$145.00; (3) 95 gal cans = \$240.00; (2) 95 gal cans + (1) 65 gal can = \$160.00 & (4) 95 gal cans = \$280.00 per quarter depending on the amount of Refuse generated.

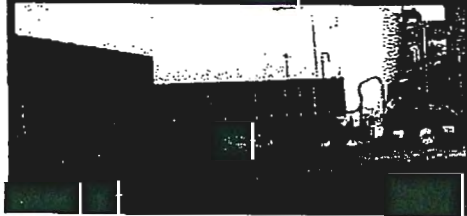
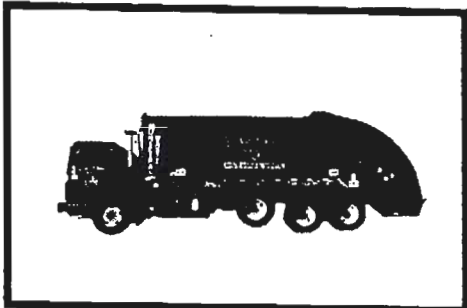
We have been delivering our materials to the Consortium Recycling Transfer Facility which we have owned for over 15 years. We have been in a contract with RE Community since it opened.

RECOMMENDED BOARD ACTION

Motion to enter into a contract with J. P. Mascaro Inc, for the Processing, Marketing and Running the Transfer Facility on Fitzwatertown Road as per bid specifications.

COMMENTS

1. Our costs for 2015 will be \$34.57 per Ton for our Commingle and \$30.92 for our Single Stream. Last year we were getting paid over \$17.00 per Ton for our Recyclables. The new contract represents a shortfall in the 2016 Budget of over \$154,000.00 when factoring in the revenue loss and the over \$30.00 fees for Processing and Running the facility. This has been factored into the 2016 presented Budget and through some timely revenue increases, better utilization of Personnel and some other factors, we are proposing a no fee increase in 2016 despite the shortfall.
2. I have attached a Bid Tab from the two bidders, J. P. Mascaro and RE Community Recycling.

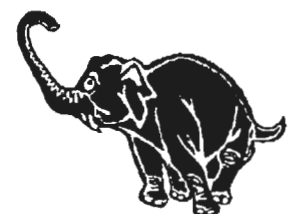

C. Bidder will add these 5 values together and get a total of \$0.735.

E. Bidder would then take the \$0.147 cents per pound and multiply by 2,000 pounds and arrive at a final value of \$294.00 per ton.

- 4) Our company has 50 years experience in all aspects of the solid waste industry including recycling related services; specifically we operate 3 DEP permitted transfer stations where recyclables are received and processed and operate 2 additional stand-alone recycling facilities. In addition, we also own and operate 3 compost facilities and a yard waste facility.
